# Privacy Notice (Last updated on June 11, 2025)

This privacy notice for Rainforest RN, LLC describes how and why we might access, collect, store, use and/or share your personal information when you use our services, including when you:

- use in-home nursing services, including foot care, medical pedicures, manicures, wound care, vital signs monitoring, health history-taking, medication assistance and other ancillary nursing services
- participate in sales, marketing or events

## Summary of Privacy Notice Key Points

When you visit our website or use our services, we may process personal information depending on how you interact with us, the services you use, and your choices.

Some information may be considered sensitive such as race, ethnicity or sexual orientation depending on jursidiction. We do not process sensitive information. Rainforest RN only collects health information as it relates to your care. This information is not shared and is stored in a secure electronic health record. Information regarding clients may only be shared with other health care professionals and only if a release of information has been signed by the client.

We do not collect information from third parties.

We process your information to provide, improve and administer our services, communicate with you, to comply with security fraud prevention laws. We process your information when we have a legal reason to do so, and may process your information for other reasons with your consent.

In spite of cyber security measures established through our website and electronic health record, no electronic platform is ever entirely secure and we cannot guarantee your personal information will not be accessed via hackers, cyber criminals, or other unauthorized third parties who may be able to access your personal information.

Depending on your location, you may have the right to file a data subject access request. We will comply with your request according to the laws in our jurisdiction.

What Information is Collected?

Our website, rainforestrn.com, collects information that you voluntarily provide, such as name, phone number, email, and mailing address. We do not collect or process sensitive information.

Our website, hosted through a third party platform, may also collect usage data such as your IP address, location, device information, browser type, and data usage on our platform. This information is collected for the purposes of data analytics to improve the performance of the website.

The information collected in home visits is stored in a secure electronic health record. When you consent to services, you are consenting to have this information collected and stored in the secure electronic health record.

The information gathered from rainforestrn.com may be shared with data analytics teams, website hosting services, and performance monitoring teams. These individuals commit to protecting your information and use it only for the purposes of improving website performance. Your information may be shared in the even of a business transfer.

Our website, rainforestrn.com may use cookies and other tracking modes to gather data analytics information, and third parties we engage with to provide data analytics and web hosting may also use cookies and other tracking modes on our website.

Your information is kept for 2 years or when you are no longer a client of our service.

We do not collect information from minors, unless an authorized adult has consented to services for a minor through rainforestrn.com.

You have the right to request that your personal information be removed from our website database. Our website hosting service uses built-in cookies.
